We have provided a map of Genoa with details of places significant to your visit.



## HOMAGE TO FRANCESCO BERLINGIERI CMI PRESIDENT AD HONOREM

This is the third CMI Assembly to take place in Genoa. The first was in September 1925 and the second in June 1992. The 1925 Assembly was chaired by Prof Francesco Berlingieri Snr, the grandfather of the CMI paterfamilias whom we have come to Genoa to honour now, some 92 years later. 'Our' Francesco Berlingieri, was born three years before the 1925 Assembly. And if you take a look at the attendance register of the 1925 sessions, Prof Avv Giorgio Berlingieri was also present. He was the grandfather of our current Senior Vice-President, also Giorgio.

Francesco has dedicated a lifetime of service to the CMI, and we are honoured and humbled that he will join us for CMI 2017 Genoa.
