Shipping and the Challenge of Decarbonisation

IMO's contribution to the global fight against climate change was enhanced with the adoption of the 2023 IMO Strategy on reduction of Greenhouse gas (GHG) emissions from ships.

The strategy envisages, in particular, a reduction in carbon intensity of international shipping and contains a commitment to ensure an uptake of zero or near zero GHG emission technologies, fuels and/or energy sources by 2030.

As decarbonisation is one of the most significant challenges of our era, the Comité Maritime International – CMI, also considering its longstanding cooperation with IMO, in 2023 created an International Working Group on decarbonisation to deal with the legal issues which the maritime sector is facing in the transition towards decarbonisation.

This Seminar, jointly organized by the Italian and French Maritime Law Associations, two of the oldest Maritime Law Associations members of the CMI, constitutes a moment of discussion and advancement on this highly topical and international relevant matter and addresses on the three related areas of Green Ships, Green Fuels and Green Contracts.
